In compliance with item No. 4 of the General Information Sheet (GIS) General Instructions for Stock Corporation, we respectfully revise the GIS for the year 2018 of Ginebra San Miguel Inc. (GSMI), reflecting the changes in the list of stockholders, specifically to update the number of shares of PCD Nominee Corporation (Filipino), San Miguel Corporation (SMC) and other stockholders (OTHERS), as well as to include San Miguel Food and Beverage, Inc. (SMFB) as GSMI's stockholder of 216,972,000 common shares (GSMI Shares).

The circumstances under which the said changes pertaining to SMC and SMFB were made, are as follows:

- (a) On April 6, 2018, GSMI filed SEC Form 17-C to inform the Securities and Exchange Commission (SEC) about the Deed of Exchange executed by and between SMC and SMFB (Deed) whereby SMC, among others, agreed to convey and transfer to SMFB the GSMI Shares. In exchange, SMFB will issue common shares (SMFB Shares) in favor of SMC upon approval by the SEC of the increase in the authorized capital stock (ACS) of SMFB.
- (b) On April 13, 2018, SMC and SMFB filed with the Bureau of Internal Revenue (BIR) a request for a confirmatory tax-free exchange ruling of the GSMI shares for SMFB shares covered by the Deed, which to date, has not yet been issued.

- (c) On June 29, 2018, the SEC approved the increase in the ACS of SMFB. Conformably with the Deed, SMFB issued shares to SMC in exchange for its GSMI Shares.
- (d) On July 6, 2018, SMFB and SMC filed SEC Form 23-A and SEC Form 23-B, respectively, with the SEC relative to their respective shareholdings in GSMI. However, the registration of the GSMI Shares and the SMFB Shares in the respective Stock and Transfer Books of GSMI and SMFB have been deferred pending receipt of the abovementioned ruling and the Certificate Authorizing Registration from the BIR.

Conformably with SEC Memorandum Circular No. 16, Series of 2016, revising the GIS form, we submit the revised pages 1, 4-6 of the above-mentioned GIS of GSMI containing the aforementioned change.
