The Company registered a robust performance in the third quarter of 2023, posting a 13% growth in revenues to Php38.9 billion. Income from operations ended at Php5.0 billion, up 10% over the same period last year. Meanwhile, net income reached Php5.5 billion, 62% higher from the previous year, including a one-time gain from the transfer of product rights for the Don Papa brand.
