We would like to inform the Securities and Exchange Commission that in the case entitled "In the Matter of the Water Pollution Control and Abatement Case vs. Distileria Bago, Inc.", docketed as DENR-PAB Case No. NIR-F02217-25, the Department of Environment and Natural Resources-Pollution Adjudication Board (DENR-PAB) in an Order dated July 20, 2026 (the "DENR-PAB Order"), imposed on Distileria Bago Inc. (DBI), a wholly-owned subsidiary of Ginebra San Miguel Inc. (GSMI), a fine amounting to Six Million One Hundred Eighty Nine Thousand One Hundred Fifty Pesos (Php 6,189,150.00) for allegedly discharging effluents which do not meet the DENR General Effluent Standards as set out in DENR Department Administrative Order 2016-08, as provided under Republic Act No. 9275 or the Philippine Clean Water Act of 2004 and its Implementing Rules and Regulations. Pursuant to the DENR-PAB Order, DBI is given a period of fifteen (15) days from receipt thereof to pay the aforementioned amount. The DENR-PAB Order was received by GSMI today, July 31, 2026, from the Plant Manager of DBI's Plant located in Bago City, Negros Occidental. The said DENR-PAB Order was received by DBI on July 30, 2026.

DBI has implemented the appropriate measures to address the aforementioned effluent discharge and to comply with the effluent standards of the DENR.

Pursuant to the requirements of the Securities Regulation Code, the registrant duly caused this report to be signed on its behalf by the undersigned hereunto duly authorized.
